**Visa Requirements:**

1. Duly filled-in application form in CAPITAL LETTERS
2. Two recent passport size coloured photographs (3.5cm x 4.5cm) with light blue background
3. Original Passport (valid for a minimum of 6 months) along with a copy of first page and copies of previous visas of Pakistan.
4. In case of Foreign Passport, a copy of the Dutch Residence Permit Card
5. In case of business visa, business card, a letter of invitation from Pakistan based company and guarantee letter of local company are required
6. A copy of flight booking or ticket
7. In case of tourist visa, a letter from any registered tourist organization in Pakistan is required
8. In case of visit visa, a valid original letter of invitation along with CNIC of invitee, both duly attested by the local authorities.
9. The visa fee of €72/- which is non-refundable
10. In case of children of Pakistani origins born abroad, the Birth Certificate or any other document showing the name of parents and copies of parents passports/IDs
11. In case of foreign spouses of Pakistani origin, the marriage certificate duly attested by concerned authorities.
12. In case of family reunion visas of Pakistani origin, proof of Pakistan origin is required

Note: The processing time for all visas is at least 3 working days after submission of the application.
